Grade Level:	12
Length:	1 Year
Period(s) Per Day:	1

ESSENTIAL UNDERSTANDING:

Advanced Placement English Literature and Composition “engages students in the careful reading and critical analysis of imaginative literature. Through the close reading of selected texts, students deepen their understanding of the ways writers use language to provide both meaning and pleasure for their readers. As they read, students consider a work’s structure, style, and themes as well as such smaller-scale elements as the use of figurative language, imagery, symbolism, and tone”(The College Board, AP English Literature and Composition Course Description, 2016-2017, p. 4). Students will study literary works from a variety of genres and periods. Students will write expository, analytical, and argumentative essays.

Course Objectives and Expectations:

- 1.) Reading a variety of literature, including classic novels, short stories, poetry, and plays
- 2.) Viewing and interpreting film, as it applies to the study of literature
- 3.) Writing literary analysis essays, some timed
- 4.) Writing a literary research paper
- 5.) Keeping a response to literature journal
- 6.) Discussing literature both in small groups, and as a class

Student Objectives:

Upon completion of AP English Literature, students will:

- 1.) Practice “close reading” strategies and respond to literature through writing.
- 2.) Focus on reading, analyzing, and responding to poetry and drama.

- 3.) Write, in addition to several short analysis essays, a literary research paper
- 4.) Continue preparing for the national AP exam through practice quizzes and essays.
- 5.) Generate new ideas, hypotheses, opinions, theories, questions...and develop strategies for seeking and synthesizing information to support an argument.
- 6.) Monitor individual thinking or behavior in order to question, confirm, validate, or correct it.
- 7.) Write and understand expository and persuasive paragraphs and essays responding to various aspects of literature.
- 8.) Maintain high standards in written work: syntax, usage, mechanics, and spelling.

L.11-12.4 Determine or clarify the meaning of unknown and multiple-meaning words and phrases based on grades 11–12 reading and content, choosing flexibly from a range of strategies, recognizing the role culture plays in the development of language.

L.11-12.4.a Use context (e.g., the overall meaning of a sentence, paragraph, or text; a word's position or function in a sentence) as a clue to the meaning of a word or phrase.
