

Advanced Composition:

Grade Level: 12
Length: 1/2 Year
Period(s) Per Day: 1

ESSENTIAL UNDERSTANDING:

Advanced Composition helps students practice the writing skills of argument, persuasion, formal and informal logic, and use of evidence. Students will also consider the elements of tone, diction, and style as they affect argument and persuasion. Finally, by writing persuasive research papers students will acquire some valuable research skills, including library work, formal documentation, and avoidance of plagiarism. Students will learn to apply these writing skills as they would use them in the workplace

Course Objectives and Expectations:

- 1.) Opinion writing, fifteen short (1–2 pages) reaction papers
- 2.) Evaluative writing, five student evaluations
- 3.) Research writing, two research papers (6-12 pages)
- 4.) Exam, two (outside of class)
- 5.) Weekly online discussions
- 6.) Small group evaluation activities

Student Objectives:

Upon completion of Advanced Composition, students will:

- 1.) Develop multiple, flexible strategies for writing, particularly inventing, organizing, drafting, revising, and copyediting.
- 2.) Demonstrate an understanding of research as a process of gathering, evaluating, analyzing, and synthesizing appropriate primary and secondary sources.
- 3.) Integrate their own ideas with those of others.

- 4.) Formulate an assertion about a given issue and support that assertion with evidence appropriate to the issue, position taken, and given audience.
- 5.) Use conventions of format and structure appropriate to the rhetorical situation and audience.
- 6.) Develop and organize logical thoughts as a means of building evidence that results in a persuasive argument.
- 7.) Understand how to self-edit and appreciate its importance in crafting a professional document.
- 8.) Demonstrate proficiency in the use of the conventions of language and forms of discourse, including grammar, syntax, punctuation, spelling, and mechanics.

W.11-12.2 Write informative/explanatory texts to examine and convey complex ideas, concepts, and information clearly and accurately through the effective selection, organization, and analysis of content.

W.11-12.2.a Introduce a topic; organize complex ideas, concepts, and information so that each new element builds on that which precedes it to create a unified whole; include formatting (e.g., headings), graphics (e.g., figures, tables), and multimedia when useful to aiding comprehension.

W.11-12.2.b Develop the topic thoroughly by selecting the most significant and relevant facts, extended definitions, concrete details, quotations, or other information and examples appropriate to the audience's knowledge of the topic.

W.11-12.3.a Engage and orient the reader by setting out a problem, situation, or observation and its significance, establishing one or multiple point(s) of view, and introducing a narrator and/or characters; create a smooth progression of experiences or events.

W.11-12.3.b Use narrative techniques, such as dialogue, pacing, description, reflection, and multiple plot lines, to develop experiences, events, and/or characters.

W.11-12.3.c Use a variety of techniques to sequence events so that they build on one another to create a coherent whole and build toward a particular tone and outcome (e.g., a sense of mystery, suspense, growth, or resolution).

W.11-12.3.e Provide a conclusion that follows from and reflects on what is experienced, observed, or resolved over the course of the narrative.
