

**Literature of the Hero:**

Grade Level: 10-11-12  
Length: 1/2 Year  
Period(s) Per Day: 1

**ESSENTIAL UNDERSTANDING:**

Literature of the Hero explores the concept of hero and the cultural heritage gained from the ancient Greeks. Through the study of Greek myths, students will gain a classical background and develop an awareness of the myth making process. Works read include: Edith Hamilton's *Mythology*, *Medea* by Euripides, *The Iliad* and *The Odyssey* by Homer.

**Course Objectives and Expectations:**

- Determine central ideas and provide accurate summaries
- Integrate and evaluate multiple sources of information
- Evaluate various explanations for actions
- Write arguments to support claims in an analysis of topics/texts
- Write narratives to develop real or imagined experiences
- Gather relevant information from multiple authoritative sources
- Cite textual evidence to support analysis of sources
- Initiate and participate effectively discussions
- Evaluate point of view and reasoning
- Present information
- Demonstrate a command of standard English
